9 Pursuant to ORS 455.895(1)(b) and OAR 918-001-0036, the Electrical and Elevator Board  
10 proposes to impose a civil penalty against you in the amount of \$1,000.

11 **FINDINGS OF FACT**

12 On or about November 2, 2006, at 724 NW 118<sup>th</sup> Ave., Beaverton, Oregon, Respondent  
13 installed electrical wiring, for the account of another, without a valid Oregon supervising or  
14 journeyman electrician's license.

15 **CONCLUSIONS OF LAW**

- 16 1. The installation of electrical wiring, as outlined in the Findings of Fact, is an electrical  
17 installation as defined in ORS 479.530(10).
- 18 2. By making an electrical installation without a valid Oregon supervising or journeyman  
19 electrician's license, as outlined in the Findings of Fact, Respondent violated ORS 479.620(3).

20 **ORDER**

21 Pursuant to ORS 455.895(1)(b) and OAR 918-001-0036, the Electrical and Elevator Board finds  
22 Respondent violated ORS 479.620(3) and is assessed a \$1,000 civil penalty.

23 **NOTICE OF RIGHT TO HEARING**

24 You are entitled to a hearing as provided by the Administrative Procedures Act, Oregon Revised  
25 Statutes, Chapter 183. If you wish to receive a hearing you must file a written request for a  
hearing with the Board no later than 20 days from the date of service of this notice. If a request  
for hearing is not received within the 20-day period your right to a hearing shall be considered  
waived unless the failure to request a hearing was beyond your reasonable control. Hearing  
requests shall be mailed to Building Codes Division, Enforcement and Licensing Section, PO  
Box 14470, Salem, Oregon, 97309.

You have the right to be represented by legal counsel. ORS 183.457 provides that a corporation

1 may be represented by an authorized representative at the hearing. If you request a hearing the  
2 Board and Director will notify you of the time and place of the hearing. The Board and Director  
3 will give you information on the procedures, right of representation and other rights of parties  
4 relating to the conduct of the hearing before commencement of the hearing.

4 **NOTICE OF FINAL ORDER**

5 If you do not request a hearing within 20 days, this citation will become a final order, effective  
6 21 days after it was served on you. If you do not request a hearing or fail to appear at a  
7 scheduled hearing, the Division's file on the matter becomes record. You are entitled to judicial  
8 review of this order. Judicial review may be obtained by filing for review within 81 days from  
9 the date this order was served. Judicial review is pursuant to the provisions of ORS 183.482 to  
10 the Court of Appeals.
