

1 **ORDER**

2
3 Pursuant to ORS 455.895(1)(b) and OAR 918-001-0036, the Electrical and Elevator
4 Board of the State of Oregon finds Respondent violated ORS 479.620(3) and is
5 assessed a \$2,000 civil penalty.

6 The Board further ORDERS that \$1,250 of the \$2,000 total civil penalty be stayed for
7 the period of five years from the date of this Order, under the following terms and
8 conditions:

9 Respondent shall not violate any provision of Oregon Building Code statutes,
10 administrative rules, specialty codes, or any order issued by the division or a State
11 Building Codes advisory board.

12 The remaining \$750 civil penalty is due and payable after this document is signed by
13 the Board. It shall be considered a failure to meet a term or condition of this order
14 should a Final Demand for Payment be issued to Respondent and Respondent fails to
15 pay the penalty within the time period stated on the Final Demand. Failure to submit
16 payment will result in collection of the entire \$2,000 civil penalty.

17 If Respondent fully complies with the conditions imposed herein, the \$1,250 stayed civil
18 penalty shall be waived at the end of the five-year period. If the Board finds that the
19 Respondent has violated any of the terms and conditions stated herein during the five-
20 year period from the date of this stipulated agreement, the Board may collect the \$1,250
21 stayed civil penalty. Further, this stipulated agreement does not limit the Board from
22 other actions to enforce other violations of the Oregon Building Codes statute,
23 administrative rules, and specialty codes.

24 **CONSENT TO ENTRY OF ORDER**

25 I, JOEL L. CRESWELL, state that I am or that I represent Respondent in this matter. I
have read the foregoing Order and by my signature attest that Respondent knows and
fully understand its contents; that Respondent consents to the entry of this Order and
admits the allegations contained in the Findings of Fact; that Respondent has been
advised of its right to a contested case hearing, and to be represented by legal counsel
in this matter; that Respondent freely and voluntarily consents to the entry of this Order
without further hearing, without any force or duress, and expressly waives any right to a
hearing in this matter.
