

1 **ORDER**

2 Pursuant to ORS 455.895(1)(b) and OAR 918-001-0036, Respondent is assessed a \$2,000 civil
3 penalty for violation of ORS 479.620(3).

4 The Board agrees to stay \$750 of the \$2,000 for the period of five years from the date of this
5 Order, under the following terms and conditions. Failure to meet any of the terms or conditions
6 contained in this order will result in the entire penalty of \$2,000 becoming immediately due and
7 payable.

8 The remaining \$1,250 is due and payable once the order is signed by the Board. It shall be
9 considered a failure to meet a term or condition of this order should a Final Demand for Payment
10 be issued to Respondent and Respondent fails to pay within the time period stated on the Final
11 Demand. Failure to submit payment will result in collection of the entire \$2,000 civil penalty.

12 The Board further ORDERS an additional \$500 be stayed from the remaining \$1,250 civil
13 penalty if Respondent remits a full payment of \$750 within 10 days of the date the ORDER is
14 signed by the Board.

15 If Respondent fully complies with the conditions imposed herein, the stayed civil penalty shall
16 be waived at the end of the five-year period and no longer imposed. If the Board finds that the
17 Respondent has violated any of the terms and conditions stated herein during the five-year
18 period, the Board may impose the stayed civil penalty. Further, this Order does not limit the
19 Board from other actions to enforce other violations of the Oregon Building Codes statute,
20 administrative rules, and specialty codes.

1 **CONSENT TO ENTRY OF ORDER**


2 I, BILL CALLAWAY, state that I am or that I represent Respondent in this matter. I have read
