

1 **ORDER**

2
3 Under ORS 455.895(1)(a) and OAR 918-001-0036, the Board assesses the following
sanction:

- 4 (1) a \$2,000 civil penalty for violating ORS 479.620(3)

5 The civil penalties assessed total \$2,000.

7 **STIPULATED AGREEMENT**

8
9 You and the Board agree to resolve this matter without a hearing according to the
following terms:

10 (1) You admit to committing the violations as alleged in the Findings of Fact and
11 Conclusions of Law and agree the Board will issue an order imposing the proposed civil
penalties for such violations in order to resolve this matter.

12 (2) The Board agrees to suspend \$1,000 of the \$2,000 in civil penalties for a
13 period of five years under the following terms:

14 (a) You agree to not commit further violations of Building Codes
15 Division's statutes and/or rules.

16 (b) You agree to pay the remaining \$1,000 of the civil penalties *or \$750 if full*
17 *payment is submitted by the due date on the invoice that is included with*
18 *your copy of the Order signed by the Board. The additional \$250 will*
then be added to the suspended amount.


19 (c) If you fail to make a payment within the time period stated on
20 the Final Demand, collection of the entire civil penalties, including any
suspended amount will be initiated.

23 (d) You understand and agree that any violation of the terms of this
24 Settlement Agreement and Consent Order will result in further
25 enforcement action.


- 1 (e) You understand and agree that any violations of Building
2 Code Division's statutes and/or rules not alleged in the Findings of Fact
3 above, whether committed before or after the execution of this
4 Settlement Agreement and Consent Order, shall be basis for further
5 enforcement action.
- 6 (f) You understand that the suspended civil penalty will be waived five
7 Years after the execution of this Settlement Agreement and Consent
8 Order, provided you comply with its terms and do not commit any
9 further violations of Building Codes Division's statutes and/or rules.
- 10 (g) You have read and fully understand the terms of this Consent
11 Order. You freely and voluntarily consent to the entry of this
12 Order without further hearing, without any force or duress, and
13 expressly waive all rights to a hearing or appeal in this matter.
- 14 (h) You understand that, upon signature of all parties, this
15 Settlement Agreement and Consent Order will be a FINAL ORDER.
- 16 (i) You understand that once this Settlement Agreement and Consent
17 Order becomes a FINAL ORDER it becomes a public document.
